#### Recommendation:

**That** the Kingston Police Service Board pass a motion to renew the Special Constable Appointment of Franco Domenico DiPietrantonio for the purposes of:

1. Transporting, searching, guarding, control, escort and conveyance of persons in custody and to perform duties related to the responsibilities of police service boards under Part XV, providing security at premises and for persons or places that are occupied or utilized as courts in accordance with ss. 95(3)(3) and Part XV of the *Community Safety and Policing Act*.
2. Execution of Warrants of Committal, service of summonses, subpoenas, and other legal documents with respect to areas where the police service board has policing responsibility.

#### Summary:

With the coming-into-force of the *Community Safety and Policing Act* on April 1, 2024, Special Constable appointments and renewals of appointments are now the responsibility of each individual Police Service Board. As such, our office has prepared an application form to facilitate this process and aid the Board in making an informed decision regarding the appointment of a Special Constable.
